Pistol Matches may be conducted at alternate times dependent upon availability of a suitable Range Officer.

**At least one Range Officer is to be present on a Range at all times when a weapon is discharged. (Weapons Act 1990)**

**Range Officer must sight each shooter's Licence and make required notation in Range Register - this is a requirement of the Weapons Act. No exceptions.**

**Unlicensed persons must complete a Form 33 issued and be signed by a Range Officer. Form to be retained by Club for 3 years. (Weapons Act)**

**Unlicensed persons must complete the Range Register and be signed by a Range Officer. (Weapons Act)**

**An unauthorised person is not permitted to discharge a weapon unless authorised by a Range Officer via a Form 33. (Weapons Act)**

**A Range Fee (\$10) is to be paid by all visiting shooters (non-members). Range Fee to be collected by Range Officer supervising visiting shooter.**
